

CHAPTER 6

TIMSS International Quality Assurance **Program**

Introduction

The International Quality Assurance Program is essential to the TIMSS Survey Operations Procedures. The goal of the quality assurance program is to document data collection activities and verify the implementation of the standardized procedures across countries. The documentation provides evidence of the quality of data collection and information that might aid in interpreting the TIMSS results. The program also provides feedback to all those involved in the data collection procedures to improve future administrations. This chapter provides an overview of the TIMSS International Quality Assurance Program and reports on the data collected through the program for the 2023 cycle.

In each TIMSS assessment cycle, standardized assessment materials and survey operations procedures are developed and adapted from previous cycles so that the data collection meets the highest standards. As part of the quality assurance program, International Quality Control Monitors (IQCMs) are selected and appointed in each TIMSS country to implement the program by visiting a sample of participating schools to observe the TIMSS administration.

Role and Responsibilities of the TIMSS International Quality Control Monitors

An important aspect of the International Quality Assurance Program is that the IQCMs are hired independently from the national centers responsible for implementing TIMSS in the participating countries. IQCMs are selected mostly from among individuals who had served in this position in previous IEA studies. For new countries and in cases where previous individuals are unavailable, the National Research Coordinators (NRCs) may assist in nominating new candidates. However, the IQCMs cannot be members of the national center staff, family members, or personal friends of the NRC. Those nominated often have prior experience as a retired schoolteacher, school inspector, or ministry official. The qualifications for the position include fluency in English and the national language(s).





Prior to the start of the data collection for each TIMSS cycle, all IQCMs attend a training session to learn about their role and responsibilities as well as the TIMSS Survey Operations Procedures. In addition to attending the mandatory training session, IQCMs receive a video recording of the training session, a manual describing their duties and responsibilities, and all necessary documents and forms to complete their tasks.

The main task of the IQCMs is to conduct site visits during the data collection process and record their observations. The IQCMs in each country visit a sample of 15 participating schools per grade during the assessment administration. When one or more benchmarking entities from the same country participate, and a single centrally-organized national center is responsible for all aspects of the data collection, the IQCM visits five additional schools in each benchmarking region to the schools visited for the country as a whole. IQCMs can recruit assistants to help cover their country's geographic territory and maintain the necessary testing timeline.

The responsibilities of the TIMSS IQCMs include the following:

- Collect from the national center copies of the national School Coordinator and Test Administrator manuals, tracking forms for the selected classes, and, in case of any paper instruments, a copy of each instrument.
- Review the survey operations procedures manuals and test administration scripts, comparing the national and international versions and documenting any substantial differences.
- Prepare a list of eligible schools, select the ones to be visited, and contact the School Coordinator for each school to arrange the visit.
- Observe the TIMSS testing session in each school visited and record observations in the online Classroom Observation Record, noting any deviations from the standardized administration script, timing, and procedures.
- Interview the School Coordinator and the Test Administrator in each school visited.
- Submit all required documentation, including manuals and observation records, to IEA for review.

Quality Control Observations of the TIMSS 2023 Data Collection

In TIMSS 2023, IQCMs visited and observed digital test administrations in 812 fourth-grade sessions and 596 eighth-grade sessions. In addition, paper-based test administrations were observed in 122 fourth-grade sessions and 62 eighth-grade sessions. Altogether, IQCMs observed 1,592 testing sessions for TIMSS 2023.

Mandatory training for IQCMs took place in January 2023 for Northern Hemisphere countries and in July 2023 for Southern Hemisphere countries. Then, IQCMs conducted site





visits to a sample of participating schools during the data collection period to document the test administration procedures. IQCMs conducted interviews with the School Coordinator and Test Administrator during the school visits to gather their feedback on the TIMSS 2023 assessment materials and procedures. They also completed a Classroom Observation Record for each visit, detailing their findings and submitting their observations online via the digital platform SoSci Survey.

The records submitted by IQCMs were organized into the following sections for each school visited:

- Section A: Preliminary Activities
- Section B: Administration Process
- Section C: Summary Observations
- Section D: Interview with the School Coordinator and Test Administrator

Section A addressed activities that took place just prior to and during the testing sessions, and Section B addressed all activities during the testing session, including the achievement test and student questionnaire administration. The assessments were administered in two parts with a break of up to 30 minutes between each part. During test administration, IQCMs were asked to observe the activities of the Test Administrator, such as distributing, collecting, and securing the testing materials; following the assessment administration script; and timing the testing sessions. In Section C, IQCMs summarized observations on overall student cooperation and compliance with instructions during the assessment administration. Finally, in Section D, IQCMs reported on the interviews with the School Coordinator and Test Administrator. The interview addressed issues such as the following:

- shipment of assessment materials
- arrangements for test administration
- responsiveness of the national center to queries
- necessity for make-up sessions
- organization of classes in the school (to validate the within-school sampling procedure)

The results of the TIMSS 2023 International Quality Assurance Program are reported in the subsections below according to this organization of the online record, with percentages of IQCM responses on all activities presented in exhibits. A "Not applicable" code was assigned to responses in cases for which a question was not shown due to logical filtering. Because of rounding, some results may appear inconsistent. Results for paper-based testing sessions are reported separately because the observation record was different.

Preliminary Activities

Overall, IQCMs reported that the TIMSS 2023 assessments were conducted in accordance with the international procedures. The IQCM responses on the preliminary activities for TIMSS 2023 are reported in Exhibit 6.1 for fourth-grade sessions, and in Exhibit 6.2 for eighth-grade





sessions. Exhibits 6.3 and 6.4 report results for paper-based sessions for fourth grade and eighth grade, respectively.

IQCMs reported that 78% of fourth-grade and 82% of eighth-grade testing sessions had the School Coordinator in the room, and that 65% of fourth-grade and 75% of eighth-grade testing sessions had an Information Technology (IT) specialist in the room prior to testing. For both digital and paper administration, other people who had access to the classrooms in advance of the testing session included school principals, classroom teachers, and members of the national centers.

Approximately 80% of Test Administrators set up the devices with the initial login credentials for testing prepared for students before their arrival. In the other instances, students received the login credentials from the Test Administrator as they entered the room and were required to log in to their own device or one assigned to them. Almost all IQCMs observed that Test Administrators ensured that students were sitting at the appropriate computers.

With regards to the types of devices used for administering TIMSS to students, it was noted that when the primary device was desktop computers, approximately 26% of fourth-grade and 16% of eighth-grade classrooms also used portable computers. When the primary device was portable computers, approximately 16% of fourth-grade and 18% of eighth-grade classrooms also used desktop computers. In classrooms where the primary device was tablets, there were very few cases of portable or desktop computers also being used.

For the countries administering TIMSS 2023 on paper, almost all IQCMs reported that test administrators distributed the test booklets according to the booklet assignment on the Student Tracking Form and the booklet labels.

Administration Process

Exhibits 6.5 through 6.8 report on the activities conducted during the testing sessions.

To standardize test administration, all Test Administrators were instructed to read the script in the Test Administrator Manual to the students. IQCMs reported that in more than 70% of the TIMSS 2023 observations, the Test Administrators followed the script exactly. The deviations from the script were mostly minor. Examples of the deviations included the repetition of instructions, simplification of instructions, adaptation of written language used in the instructions to the spoken language, answering and clarifying student questions about instructions, providing more explanation of the examples, and adding instructions of what students should do if they finished early. Examples of the deviations that were viewed as "major" included the Test Administrator not reading the script word for word, paraphrasing of instructions, adding explanations and clarifications of instructions, or omitting some text from the text (e.g., instructions that the students could read for themselves within the test materials).

In accordance with the procedure at the end of the digital testing session for TIMSS 2023, Test Administrators were asked to secure the testing devices and USB sticks. The IQCMs





reported that this instruction was distinctly followed in 88% of the fourth-grade testing sessions and in 87% of the eighth-grade sessions. After each paper-based session, Test Administrators were asked to collect and secure the test booklets. The international monitors reported that this occurred in 88% of the paper-based fourth-grade and 90% of the paper-based eighth-grade sessions.

The mode of administration for the TIMSS 2023 Student Questionnaire was identical to that of the assessment (e.g., students that were administered the assessment digitally were also administered the student questionnaire digitally). Exhibits 6.9, 6.10, 6.11, and 6.12 summarize the IQCMs' observations of the student questionnaire administration for fourth grade and eighth grade, for digital and paper instruments, respectively.

A number of classes did not have a break between the achievement testing sessions and the start of the student questionnaire administration (20% for fourth-grade TIMSS, 23% for eighth-grade TIMSS, 9% for fourth-grade paper-based TIMSS, and 18% for eighth-grade paper-based TIMSS). In other classes, students had a longer break between the two, had a few moments for a quick snack and bathroom break, or took a much longer break for lunch.

Most IQCMs reported that the Test Administrators followed the administration script for the student questionnaire. In cases where the Test Administrator deviated from the script, most of the modifications were reported to be "minor." As with the directions for the achievement instruments, examples of the deviations from the script included the repetition of instructions, clarifying instructions, simplifying and rephrasing the instructions, adapting the written language





of the instructions to the spoken language, and asking students to read the example questions themselves rather than reading them aloud.

Summary Observations

Exhibits 6.13 through 6.16 summarize observations on overall student cooperation and compliance with instructions during the assessment administration. In only 2% of fourth-grade and 3% of eighth-grade observations did a student refuse to take the test. For paper-based observations, only 1–2% of students at each grade level refused to take the test. In all cases, the proper procedure was followed for excusing the student.

In the majority of the observed classrooms, IQCMs did not observe evidence of cheating (95% for fourth-grade TIMSS, 90% for eighth-grade TIMSS, 96% for fourth-grade paper-based TIMSS, and 100% for eighth-grade paper-based TIMSS). In the classrooms where IQCMs thought that cheating was observed (e.g., by students attempting to look or looking at other students' screens, talking to other students, or trying to use their mobile phones), IQCMs noted that the Test Administrators worked quickly to intervene and stop the students from sharing work or answers.





The large majority of students (98% for fourth-grade TIMSS, 96% for eighth-grade TIMSS, 93% for fourth-grade paper-based TIMSS, and 95% for eighth-grade paper-based TIMSS) followed the direction to store away everything, including electronic devices, for the duration of test administration.

In over 90% of the classrooms, students were described as extremely or moderately orderly and cooperative (95% for fourth-grade TIMSS, 93% for eighth-grade TIMSS, 94% for fourth-grade paper-based TIMSS and 96% for eighth-grade paper-based TIMSS). In the classrooms where the students were not listed as extremely orderly and cooperative, IQCMs were asked to document whether the Test Administrators made an effort to control the situation. For these cases, the Test Administrator made at least some effort to control the situation in 94% of the fourth-grade TIMSS, 95% of the eighth-grade TIMSS, 97% of the fourth-grade paper-based TIMSS, and 85% of the eighth-grade paper-based TIMSS classrooms.

Exhibits 6.17 and 6.18 report on the IQCMs' general observations of the TIMSS 2023 fourthand eighth-grade assessment administrations, and Exhibits 6.19 and 6.20 report on the IQCMs' general observations of the paper-based administrations.

During the digital testing sessions observed by IQCMs, some technical problems did occur. They ranged from internet connectivity issues and software issues (e.g., being logged out, having difficulty or inability to scroll) to hardware issues (non-functioning external keyboard or mouse, corrupted USB stick). When technical issues were reported, most Test Administrators were able to resolve the problem effectively. Most classrooms where TIMSS was administered digitally also had an IT staff member present to provide support (71% for fourth-grade TIMSS and 79% for eighth-grade TIMSS).





In most of the observed testing sessions, IQCMs found the condition of the test rooms to be suitable (93% for fourth-grade TIMSS, 93% for eighth-grade TIMSS, 88% for fourth-grade paper-based TIMSS, and 89% for eighth-grade paper-based TIMSS). Issues noted with the condition of the test rooms included temperature control (mostly too warm), noise from outside the classrooms, and lack of space. Overall, IQCMs reported the quality of testing sessions as good, very good, or excellent (96% for fourth-grade TIMSS, 94% for eighth-grade TIMSS, 96% for fourth-grade paper-based TIMSS, and 95% for eighth-grade paper-based TIMSS).

Exhibits 6.21, 6.22, 6.23, and 6.24 show the overall ratings by School Coordinators for TIMSS 2023 fourth-grade, eighth-grade, paper-based fourth-grade, and paper-based eighthgrade sessions, respectively. Almost all School Coordinators reported that the TIMSS 2023 administration in their school went "very well" or "satisfactorily" overall (97% for fourth-grade TIMSS, 98% for eighth-grade TIMSS, 91% for fourth-grade TIMSS administered on paper, and 100% for eighth-grade TIMSS administered on paper). In addition, the School Coordinators noted that the School Coordinator Manual worked well for them, and most other school staff members had positive attitudes toward TIMSS testing.

Exhibits 6.25 through 6.28 present the details of the School Coordinator interviews for TIMSS 2023. Prior to the testing day, most School Coordinators were able to check the shipment of materials from their national centers. More than 80% of the School Coordinators across the digital and paper-based administrations reported that the national centers were responsive to the school's questions and concerns.

When IQCMs asked if the System Check Program was run by the School Coordinator, 76% of the fourth-grade and 85% of eighth-grade School Coordinators reported that they ran the program on some or all of the devices. In the cases where the School Coordinators did not run the System Check Program, they reported that this was because the program was run by the Test Administrator, IT staff, or NRC.

IQCMs were instructed to ask School Coordinators how many classes of the tested grade were in the school, how many were selected to participate, and whether the School Coordinator provided the list of classes to the national center. Over 90% of TIMSS 2023 School Coordinators confirmed that they sent a complete list of classes to the national center. When IQCMs asked School Coordinators whether all students participating were listed on the Student-Teacher Linkage Form, a majority replied yes. When the School Coordinators replied no, in most cases this was related to students that left the school or new students that arrived after the Student-Teacher Linkage Form had been completed.

As a reflection of the successful planning and implementation of TIMSS 2023, approximately 90% of the interviewed School Coordinators said that they would be willing to serve as a School Coordinator in future international assessments.

Prior to administering the TIMSS 2023 Student Questionnaire and Home Questionnaire, 93%of fourth-grade, 91% of eighth-grade, 88% of paper-based fourth-grade, and 79% of paper-based eighth-grade students and/or their parents were informed about the collection of their personal data for use by the NRC and IEA for research purposes. the students and/or their parents included phone calls, text messages, emails, letters from the NRC, letters from the Ministry or Department of Education, classroom announcements, postings on school platforms, and online or in-person meetings with school officials.

Prior to administering the TIMSS 2023 Teacher and School Questionnaires, 90% of fourth-grade, 87% of eighth-grade, 88% of paper-based fourth-grade, and 79% of paper-based eighth-grade teachers and principals were informed about the collection of their personal data for use by the NRC and IEA for research purposes. The methods for informing the teachers and principals included emails, text messages, letters from the Ministry or Department of Education, staff newsletters, staff meetings, and personal conversations with the School Coordinator and/or principal.

In 34% of the TIMSS fourth-grade, 48% of the TIMSS eighth-grade, 28% of the paper-based TIMSS fourth-grade, and 42% of the paper-based TIMSS eighth-grade observed sessions, School Coordinators reported that students received incentives. Examples of the incentives provided to students included certificates of participation, stickers, pens, sunglasses, coupons, and food.

In addition, in 21% of the TIMSS fourth-grade, 30% of the TIMSS eighth-grade, 6% of the paper-based TIMSS fourth-grade, and 6% of the paper-based TIMSS eighth-grade observed sessions, School Coordinators reported that teachers and/or school principals received incentives. Examples of the incentives provided to teachers and school principals included a letter of appreciation, certificates, and gift cards.

Exhibits 6.33, 6.34, 6.35, and 6.36 show the overall ratings by Test Administrators for TIMSS fourth-grade, TIMSS eighth-grade, paper-based TIMSS fourth-grade, and paper-based TIMSS eighth-grade sessions, respectively. Over 70% of the interviewed Test Administrators did not report experiencing any problems during the administration. Those that did experience issues reported that most were related to technology or software issues.

As a reflection of the successful planning and implementation of TIMSS 2023, over 90% of the interviewed Test Administrators for both digital and paper-based TIMSS said that they would be willing to serve as Test Administrators in future international assessments.
